In this role, you will liaise with, and develop relationships and networks with stakeholders and communities to support Aboriginal participant access to the Safe Haven Facilities.

You will leverage your program delivery and co-design experience to utilise a co-design framework to support the development, implementation and ongoing review of the Safe Haven program.
